# 1. EXECUTIVE SUMMARY

---

## 1.1 INTRODUCTION

This Institution was started first under the auspices of ‘SaraswatiShikshan Samiti’ in the year 1958. This samiti was founded by Late Kuldeep Sahay, Secretary Late Sharda Prasad Verma, members Late Mahaveer Sharma, Late Laksheshwar Paliwal and Pt. Shiv Prasad Sharma. It was overtaken by the state government in 1975 and was renamed in the name of the most famous Barrister and the freedom fighter of the region Barrister Thakur Chhedilal. Shri Satya Sahay Srivastava was the first Principal of Thakur Chhedilal Govt. College, Janjgir. Earlier the classes were consisting of only Arts programmes. Undergraduate law programme was also started in the year 1983. The first building of this institution was situated near the Kutchery Chowk, Janjgir and was shifted around twenty-five years ago to its present location in Khokhra, Janjgir.

The tagline of this institution is ‘*Vidyaya Vindate Amritam*’ i.e. Vidya se manushya Jeevan ka amrit prapt karta hai (Learning bestows the nectar of life). The tagline of the college signifies its philosophical vision and the output it plans to share in the society longing to excel in the field of higher education. This institution is working in the district of Janjgir-Champa in the state of Chhattisgarh as a lead college administering 17 other government and government aided colleges apart from more than 35 private colleges of this district. The programmes being offered presently are in the stream of Arts, Sciences, Commerce and Law. There are 16 post graduate programmes and 19 graduate level programmes being offered by the college apart from two programmes DCA (Diploma in Computer Application) and PGDCA (Post Graduate Diploma in Computer Application) programmes started in session 2018-19. There are research centres in Economics and Sociology. Students from varied spheres of life and different strata of society are getting benefitted by this institution. A separate study centre of Pt. Sundarlal Sharma Open University is also situated within its premises. Two separate units of NSS are functional in this college. NCC unit having an increased strength of 107 from the previously existing of 54 is also a special feature of the college.

### **Vision**

We being the lead college of the district have the vision to excel in the field of higher education and to inculcate in the students a sense of complete and matured persona by imbibing the art of knowledge, compatibility, facing challenges of life and securing desired goals eventually. The students from distant places of the district and other nearby districts are the forerunners in many fields of study of PG level and study of law etc. In many fields we are serving with a vision to create a success story even after many a challenges.

### **Mission**

The various missions in order to achieving the long term and ultimate vision of this prestigious institution are multitudinous:

- To strive hard in the field of scientific study and research to meet desired goals.
- To excel in the field of arts, humanities and research.

- Being the sole government institution imparting legal study where students from very distant places come to study, it is also our mission to excel in the field of legal study and legal research.
- Imparting knowledge with career-oriented skills in the field of arts, science, commerce, law, computer skills by regular career counselling at department level.
- To instill in the students, sense of national responsibility to think for the nation building after fulfilling all the career-oriented aspirations.
- To create an atmosphere for students to study with more practical and research minded approach.
- To provide them with more open e-resources in library to equip them with more national and international available study materials and resources.
- It is our mission to even provide the students an environment for various competitive examinations by availing online resources, books for competitive examinations and journals of importance and repute etc.
- To serve the society and make the students sensible towards it by community outreach and extension activities.
- It is our motto to sensitize the students in particular and through them the society in general about green practices and environmental protection.

## 1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

### Institutional Strength

There are many strengths of this institution which are mentioned as under:

- The diversity of the students from different strata of the society.
- Being the lead institution there is a sufficient strength of teaching faculty with many from other parts of the country.
- More than 50% of the faculties are PhDs in their respective fields of study, 8 teachers recognised as research guides by the affiliating university and there are 2 research centres.
- Programmes are offered in the four streams of study i.e. Arts, Sciences, Commerce and Law.
- The college serves the society in the field of higher education and through various extension activities by NSS, NCC, Red Cross, Science Club, Red Ribbon Club, Legal Aid Clinic etc.
- Maximum faculty members are using ICT for effective teaching-learning process.

### Institutional Weakness

Various weaknesses of this institution include-

- Students from different backgrounds needs special attention and mentoring with extra effort.
- There is a dearth of permanent faculty in some of the disciplines which in many ways affects the teaching learning process.
- The less awareness of the lab assistants and lab technicians about ICT acts as stumble block in the qualitative teaching practice.
- Insufficient sanctioned posts for Lab Technicians.

### Institutional Opportunity

- The institution is in the process of improving its infrastructural needs including the smart classrooms and ICT facilities.
- The library facilities are also being increased with the addition of more journals including online journals and more e-resources.
- Students are full of caliber and need more objective guidance and focus towards career-oriented goals.
- More law students are being sent for internship to the district court and high court and more results can be expected in various competitive examinations.
- The institution can serve the society in an increased manner by providing more placements and societal outreach and extension tasks.

### **Institutional Challenge**

- The college is lacking in faculties and also the benefits of Associate Professors and Professorship in the field of higher education and research activities.
- The diversity of students from different strata of society pose challenges in the form of slow learners and lack of communicative skills which requires to be taken extra care of by putting in extra efforts in this respect.
- Students from very distant places have attendance problems at times though we have separate girls' hostel but facility for boy students is still lacking.

## **1.3 CRITERIA WISE SUMMARY**

### **Curricular Aspects**

The institution has a well-planned procedure through which the curriculum is delivered as per the academic calendar. The teaching plan is first prepared based on which the teaching diary is readied which indicates the whole pattern of curriculum delivery. There is also a procedure for the continuous internal evaluation of the students. The teachers of the institution regularly participate in the Academic council/ BoS of affiliating university. They are also fully involved in design and development of curriculum for various courses, setting of question papers and and assessment /evaluation process of the affiliating university. The curriculum designed by the affiliating university is having many elective courses and is also enriched by various course contents like professional ethics, gender, human values, environment and sustainability. There are many programmes having courses with experiential learning through project work/field work/internship etc. The institution also takes feedback from various stakeholders like students, teachers, parents etc. on the syllabus of various programmes offered by it and the analysis is sent to the affiliating university with related suggestions for probable incorporation into the curriculum.

### **Teaching-learning and Evaluation**

There is a good number of enrolment in most of the programmes at both UG and PG level. The students from distant places opt for its programmes and only those get through who come in the merit. The seats reserved for different categories are filled every year as per the rules of the state government. Most of the seats for STs remain vacant which is consequently filled by the SC students in the merit. The seats for OBCs are fully filled. The students are categorised into advance and slow learners based on their learning levels. The learning levels are assessed by all the departments on different criteria i.e. previous examination results, internal assessment

etc. Though there is sufficient student-teacher ratio in the institution yet there are some vacant posts of teachers which are required to be filled to increase the ratio to required level. To enhance the learning experience of the students the teaching-learning process is full of student centric methods like experiential learning and participative learning. Problem solving methodologies are also used for this purpose. Most of the teachers are presently using ICT tools like projector, screen, various online mediums etc. There is a mentor-mentee scheme by which the students are allotted mentors for redressing their academic and stress related issues. More than 50% teachers are with Ph.D. and average teaching experience of teachers in this institution is approximately 10 years. There is a well-planned procedure for internal assessment of the students and all the examination related grievances are redressed in a time bound manner. The outcomes of various programmes and courses are attained through the academic results, result of students in competitive examinations and the list of students in the merit of the affiliating university.

### **Research, Innovations and Extension**

The one teacher of one department has got research grant by the UGC. There are 8 research guides recognised by the affiliating university. The ecosystem for innovations and creation and transfer of knowledge is created through well furnished laboratories, computer centre, e-resources in the central library etc. There are many programmes conducted by the institution on the topics of research methodology, Intellectual Property Rights and Entrepreneurship. The enrolment of research scholars under the recognised research guides is still pending by the affiliating university. Some teachers have got their research papers published in the journals notified on UGC website. There are good number of books and chapters in edited volumes/books published and papers published in national/ international conference proceedings by the teachers of this institution. Extension and outreach programmes are conducted by the institution and also by NCC and NSS wings in collaboration with other agencies.

### **Infrastructure and Learning Resources**

The Institution has infrastructure and physical facilities for teaching- learning like classrooms, laboratories, computing equipments and also the Institution has adequate facilities for cultural activities, sports, games (indoor, outdoor), gym etc. The yoga centre is located in the indoor stadium of the institution. There are 6 classrooms and seminar halls with ICT- enabled facilities. The infrastructure is augmented regularly. The library facility is well equipped having more than 53 thousand books in the main library and other PG departments are also having related books. The Institution frequently updates its IT facilities including Wi-Fi with railwire service provider. The students-computer ratio in the college is 1:52 and the infrastructure is regularly maintained.

### **Student Support and Progression**

The number of students benefited by scholarships and freeships provided by the Government is around 70-75%. The institution also conducts various capacity and skill building initiatives specially in the field of yoga, health, hygiene, ICT and computing skills. The institution also conducts many career counselling programmes and students are also given guidance for competitive examinations. The grievances of students related to sexual harassment and ragging cases are timely redressed by the specially constituted committee for the purpose. A good number of students qualify in national and state level examinations like NET, SLET, Judicial Services, Police deptt., Banking, School teachers etc. There is a mechanism to induct the representatives of students in

various administrative, co-curricular and extracurricular activities related committees. The Alumni Association has been formed and the committee has also been constituted. The registration of the association is under process.

### **Governance, Leadership and Management**

There is a vision and mission document of the institution and the institution is governed with a purpose to meet these desired goals. The various committees are formed with a purpose to distribute various tasks and to assure maximum participation of the stakeholders. The Institutional Development Plan or Strategic/Perspective plan for five years is effectively adhered to. The e-governance is implemented in the areas of Administration, Finance and Accounts, Student Admission and Support and also in the area of Examination. The institution has effective welfare measures for teaching and non-teaching staffs. Some teachers have also been provided with financial support to attend conferences/workshops. The institution also conducts various professional development/administrative training programs for teaching and non-teaching staffs. Teachers also undergo online/ face-to-face Faculty Development Programmes. The performance appraisal for teaching and non-teaching staffs is done every year. The college also conducts internal and external financial audits regularly. The funds are also received from non-governmental bodies like Janbhagidari, Self finance etc. The Internal Quality Assurance Cell (IQAC) conducts regular meetings through which various quality measures are taken and analysis and assessment of various steps taken is also done through it.

### **Institutional Values and Best Practices**

The institution conducts various programmes to ensure gender equity. There are many facilities for female teachers and girl students. The institution has alternate sources of energy like use of LED bulbs for power efficiency.

The facilities for solid waste management is functional in the institution with having an MoU with the local municipality for regular collection of wastes and proper disposal. The water conservation facilities available in the institution includes Rain water harvesting, bore well, open well recharge etc. There is a large pond in the college campus located at the south-west corner. The campus is made free from plastics and automobiles are also restricted. The use of bicycles is encouraged and students also use private battery powered vehicles for travelling from their home to the college. There are more than 300 trees and saplings in the campus which makes it full of greenery. The Institution has disabled-friendly, barrier free environment for teachers and students. The Code of Conduct for teachers, students and other staffs is also implemented. Institution also organises various national and international commemorative days and events. The two best practices have also been mentioned with various distinctive features of the college.

## 2.2 Catering to Student Diversity

The ultimate aim thereby to enhance the mostly practical knowledge of the subjects and ultimately to improve their performance in the examinations and also to prepare them to be ready for fulfilling their career-oriented goals. Extra classes are also conducted as per the requirements of the students. Such students are also assisted in the revision of commonly chosen special topics.

For advance learners various steps are taken one of them being the noting down of their ambitions, various competitive examinations are also suggested according to their ambitions and calibre. They are specially guided towards higher education like research work, post doctorate, various top competitive examinations of the country and the state. ## 2.5 Evaluation Process and Reforms

### 2.5.1 Mechanism of internal assessment is transparent and robust in terms of frequency and mode

#### Response:

This institution has arts, science, commerce and Law programmes. Students from distant places come to study here. The limited seats allotted for each programme is vied by the students of the region and only with high scores and merit can get through. The challenge before the institution is to disseminate the fruit of education and knowledge in the region. Some programmes or courses are distinct to the other colleges of the region like study of law and some PG programmes like Botany, Microbiology, Biotechnology, Philosophy etc. The institution has two Research centre i.e. Economics, Sociology affiliated to the Atal Bihari Vajpayee Vishwavidyalaya, Bilaspur. These centres are created with a view to start researches in the various innovative areas of knowledge. A very good number of teachers have already completed their research work and are ready to supervise the inquisitive minds of the institution and assist the society through the outcomes of their research work. The students are enlightened in various fields of knowledge through the institution level, state level and national level seminars and workshops conducted by different departments. Some of the programmes are of interdisciplinary nature which help the students in getting the wider knowledge of the subject. Some of the departments also conducts invited lectures of various renowned personalities of the region in their particular field of expertise. Students get exposure to the distinct ways and manners in which other eminent teachers of other institutions pass their knowledge. These initiatives enhances the capabilities of the students to become at par with those of other institutions of excellence.

There are well equipped laboratories in the department of Chemistry, Physics, Zoology, Botany, Home

Science, Microbiology, Biotechnology etc. The regular and objective laboratory work by the respective students also increase their practical knowledge of the subjects. It also increases the research oriented dimension of their mental faculty. There is a big main library in the institution having more than 53 thousand of books for the students. There is a functional e-library within it. The reading area is well furnished and the facility is availed by both the teachers and students as per their requirement. The strength of the main library is also added quality to it by the other P.G. level department libraries. There is a separate library for law students. It consists of books ranging from the requirements of three years law under graduate courses to the books for four semesters law P.G. course. The sufficient books for the purposes of the research centre are also available in the other separate departmental libraries. The Reports of many commissions and committees are also available in soft form apart from the Reports of Law Commission of India in separate volume. The AIR is available for the students from the year 1950 till 2018. All of the mentioned efforts on behalf of the institution is meant to constitute an ecosystem for innovations and for creation and transfer of knowledge.

The students of this institution are very much aware of the situation and requirements of the people around it. Since most of them come from the nearby villages and town therefore they can act as forerunners in the field of holistic development of the society. The institution for the above said purposes has always engaged its students with the society, sensitized them to the issues of the nearby society and to act and add in the development of the society. The students of NSS and NCC are given regular tasks to go to the nearby villages and try to know their issues in order to assist them in coming out of it and also acquainting the society about various issues related to necessity of quality education and quality higher education, gender sensitization, rights of women and children, issues of women empowerment, knowledge of various fundamental, constitutional and legal rights given to them, road safety, communal harmony, national integration etc. Various camps are organized by the NSS and NCC cadets based on several themes. Such camps are the enlightening factors for the betterment and allround development of the society. Several outreach/Extension programmes have been conducted under the auspices of RUSA schemes.

Apart from the above the students from law department are also involved in assisting as para legal volunteers and acting in aiding and advising the members of the society who come for assistance on legal matters. Such PLVs are acting under the District Legal Services Authority. The department has a Legal Aid Clinic which also work in the same field of assisting the society and those who seek legal advices. A separate advocate is designated by the DLSA, Janjgir-Champa to aid and assist the institution and also advise separately on the issues related to legal matters free of cost to the students in particular and the society in general. The board near the entrance of the college is to inform the public at large about the free legal aid being provided in this educational institution. ### 4.1 Physical Facilities

**4.1.1 The Institution has adequate infrastructure and physical facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc.**

**Response:**

The infrastructure is created and maintained by the state government and its organizations. In the present set up the institution has a time table including the arrangement for class rooms as per the requirements of the curriculum. The department of law and commerce conduct their classes in the morning and the other departments are functional in day time. According to the requirement of the classrooms for all the programmes functional in the institution we are having insufficient infrastructure and physical facilities i.e. class rooms, laboratories, ICT, departmental library, common room, Facilities in Girls' Hostel etc. Apart from the infrastructural requirements for teaching-learning other facilities are also available in the department of chemistry, physics, botany, zoology, computer science, psychology etc. The department of computer science has sufficient number computers for the students and it further requires improvement. The main library of the institution has also got a separate computer section i.e. e-library having sufficient number of computers available for the students of the institution for getting benefit of e-resources. The P.G. level libraries are in the respective departments for hte students of different programmes. The whole building of the institution is under the CCTV surveillance for safety purposes. There is required arrangement of fire extinguisher for the safety of the institution.

**4.1.2 The Institution has adequate facilities for cultural activities, sports, games (indoor, outdoor), gymnasium, yoga centre etc.**

**Response:**

The institution has a total area of approximately 16 acres. It is equipped with all the facilities for cultural activities, sports, indoor and outdoor games, gym, Yoga centre etc. There are two big size hall named Mahanadi Hall and Indravati Hall. The Mahanadi hall is multipurpose meaning thereby it is used for Semester examinations and Annual examinations as well as at the end of the academic session all the cultural activities are conducted here earlier. The cultural activities are now conducted with the annual functions in the bigger lawn area of the college. There is another comparatively smaller lawn in front of the main entrance which is utilized mainly for beautification of the premises and during the flag hoisting ceremony. There is a big size sports ground which is used for the sports like cricket, football, hockey, hand ball, kho-kho, kabaddi etc. The indoor stadium of the college is situated behind the main building. It is one of the cynosure of the college which is used for almost all the indoor games like table-tennis, badminton, Carrom, Wrestling, Boxing, Karate and other martial arts etc. There is a separate gym which is fully equipped with almost all the necessary kits and requirements for physical exercises. There is also a

separate space for yoga purposes in the indoor stadium.

The students apart from being busy in their varied curricular tasks and semester, internal evaluations also take out time to participate in various sports and other extra curricular activities. They participate in various inter university, state level and national level sports activities in Janjgir, Bilaspur, Raipur, Banaras, Gorakhpur etc. At the end of the session they also entertain themselves through the annual functions before their final examinations. The college cultural committee and the student council collectively conduct such large scale programmes. All the activity is conducted by several sub-committees specially constituted for the purposes headed by a senior teacher and other teachers and student representatives are its members. The programmes span from two to three days. The cultural activities are held on the final day.

#### Response:

The Central Library of the college has valuable collection of more than fifty three thousand of books of the diverse subjects which cater to the needs of students, teachers and research scholars of different UG & PG level programmes. The faculty members of the college also assist in smooth functioning of library. There is a reading section attached with the library, so that students and staffs can read library books, journals, magazines, Newspapers as well as competitive examination books. The students are allowed to have issued full set of books (08-PG Students, 06 UG Students ) at a time by using their library cards. The library plays a very important role in the learning of the students as most of the students are not able to buy the required number of books recommended by the teachers due to their financial constraints.

The library is partially automated by using ILMS (Integrated Library Management System) koha. Due to the very huge collection and lack of manpower, the database creation of library books and other resources are under pipe line. ILMS Koha including various modules- Circulation, Patrons, Advance search, Lists, Authorities, ILL requests, cataloguing, serials, Acquisitions, Reports, Tools, Koha Administration, About Koha.

After completion of library resources database, we will be able to access library books through OPAC. Thus, automation of the central library of the college not only makes it easier to find books but it also makes it easier to access journals and some books online from a home computer or elsewhere by web OPAC.

### 4.3 IT Infrastructure

##### Response:

The institution has a well equipped system related to its IT facilities including Wi-Fi. The Website has been created and is regularly functional and updated. It is updated by the website updation and maintenance committee. All important notices related to academics, examinations, assignments, sports, cultural activities etc. are uploaded at regular intervals. Earlier BSNL leased line were used for providing internet facilities in the college campus. Smart classrooms were developed in 2015-16 in deptt. of chem, 2016-17 in deptt. of zoology, five wi-fi hotspots were installed in the year 2016 under the Chhattisgarh Sanchar Kranti Yojana in which one connection was in the office, central library, deptt of chemistry, deptt of physics, deptt. of Zoology. Four more wi-fi routers were made available in the academic session 2018-19. BSNL leased line has been replaced by railwire broadband for enhancing the speed and coverage of internet in the campus. There are two connections of railwire one is dedicated to the computer lab. and office the another one is utilized by all deptts, central library, laboratories etc. Smart classrooms were created in the department of Physics, Botany, Microbiology, Biotechnology, Law in the academic session 2019-20. Thus we have created a centralised structured LAN and wi-fi connections in all departments, sections, computer lab., departmental laboratories and classrooms of the institution. 24 port switch have been installed for networking of computer lab. We have 24 computer systems for practice and use of internet by the students of BSc, CS, PGDCA, DCA and other students of the college. Presently all the departments are conducting classes through online medium via google meet, zoom etc. as all the deptts are equipped with computers/laptops. The students are also provided with photocopy facilities where they can avail the on-line materials for their academic purposes.

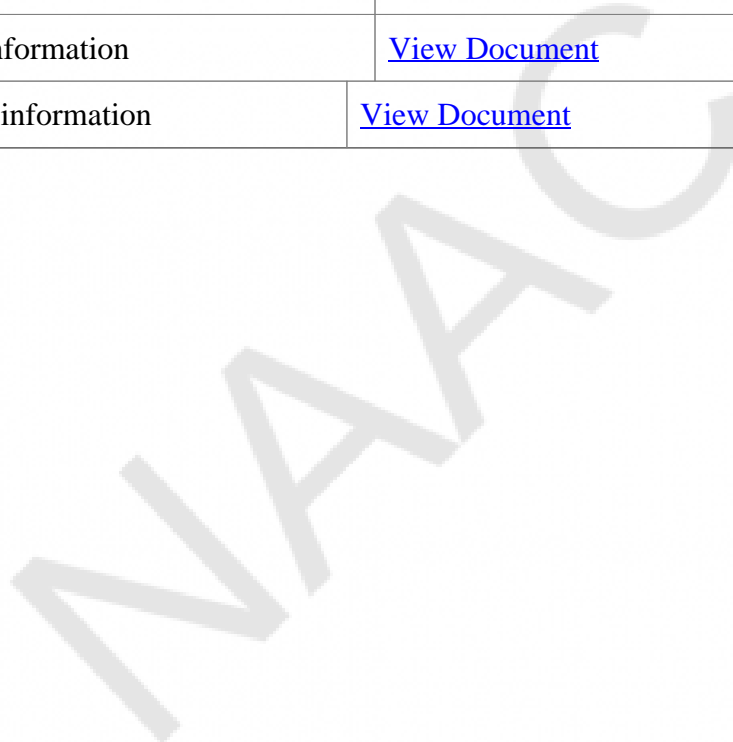
**Response:**

The institution has several committees which are entrusted with the task of maintaining and utilizing physical, academic and support facilities- laboratory, library, sports complex computers, classrooms etc. Staff Council committee has been constituted under UGC schemes for maintenance of infrastructure facilities and equipment. The Building and maintenance committee is solely responsible for looking after any major or minor civil works. There is a purchase committee which take care of all the purchase activities related to academic, support and any other facilities. Library Committee is meant to take care of library related activities. Sports committee is formed to guide the Sports department in various areas. The maintenance of physical, academic facilities are done by PWD of the state government. The maintenance of other support facilities like laboratory, library, sports complex, computers, classrooms etc. are done by the institution through various mode of expenses. The college deploys Building construction committee headed by a senior faculty member to monitoring the overall maintenance etc. Different committees are



constituted and the professor in charge/convenor are appointed to look after the maintenance of garden, green campus ,furniture,PWD works,RO water facilities maintenance,internet and wi fi facility, CTV, Cycle stand, reprographic service, computer lab, Parking zone etc.The college hire technical experts for maintenance and repair of ICT infrastructures.PWD, Rural engineering department and Janbhagidari samiti looks after the maintenance of building. Electrification and gas supply system is regularly maintained. A solar power plant is proposed to be installed in collaboration with CREDA.

Other related informations are gathered from the institutions of higher education of the district through the involvement of this institution. Therefore many such and other previously mentioned functions are divided among the faculties of the institution. ### 6.3 Faculty Empowerment Strategies

Pension benefits for the faculty appointed prior to the year 2004. Those appointed after year 2004 are eligible under the schemes of NPS. Leave and financial assistance for attending National/International seminar/conferences by state govt./UGC/DST/CGCOST/CSIR and govt. agencies. GPF loans are also permitted for marriage of children, for purchasing of car, for construction of house, for settlement of other bank loans etc. to those who have completed 15 years of service. Travelling and goods allowance is permitted in case of administrative transfer. Maternity leave, Paternity leave and Child care leave as per government rules are also given. Teachers are provided with leave for pursuing higher studies with salary as per government rules.

#### 6.4.3 Institutional strategies for mobilisation of funds and the optimal utilisation of resources

The funding agency for the institution are state government and UGC, RUSA, Research Grants, Self finance, Jan Bhagidari, ICSR, ICSSR, CGCOST. The infrastructural and other requirements of the institution are meted through the funding of the state govt. and UGC. Sometimes UGC gives funds for the infrastructural development also. College has received many grants from UGC as per the proposals sent by the UGC in charge for the establishment of Law Deptt; building, Indoor stadium, Girls Hostel, extension of Chemistry deptt., Laboratory, Gymnasium, 1st floor Hall for multipurpose use. The granted funds under Rashtriya Uchchar Shiksha Abhiyan i.e. RUSA scheme has been utilized for academic support programmes. The research grants are effectively utilized in the implementation off minor & major research projects and the purchase of necessary equipments. The fund granted by Indian Council of Scientific Research has also been used for academic purposes. Amalgamated fund- Fees collected from the students as the amalgamated fund is utilized in various student centric activities like sports activities, annual cultural activities, magazines and Periodicals in library, security measures i.e. installation of CCTV cameras. Amalgamated funds are utilized according to the Govt. finance code. Salary component- The government pays the salary of the regular teaching and non-teaching staff. Govt. of Chhattisgarh also gives order every year to appoint the teachers aginst vacant post of Asst. Professors and Professor at the begining of the Academic session on fixed wages.

## 6.5 Internal Quality Assurance System

### 6.5.1 Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes

#### Response:

The Internal Quality Assurance Cell is one of the prime committees of the institution which governs almost all the areas related to the quality improvement and assurance in the institution. Though the Principal is at the helm of all the affairs of the institution yet one of the senior most teachers of the institution is entrusted with the duty to guide its functioning. The cell consists of the teachers from almost all the departments of the college. Some members are from the alumni association and from the student council. Its structure is designed in such a manner that some members of the society also finds place in the cell. The Co-ordinator of IQAC can be only a senior teacher of the college and only for the two consecutive academic sessions. The IQAC conducts at least two meetings every year. The meetings decide the agenda or goals before the institution to improve its quality in various areas. The minutes of the meetings are decided and after the meetings the resolutions are adopted and also the ways of their implementation is discussed.

The IQAC has indeed contributed significantly in institutionalizing the quality assurance strategies and processes. The two practices institutionalized as a result of IQAC initiatives are:

1. Use of ICT from the year 2015-16 in some departments and from 2019-20 in all science departments. The need of the time is reach of the students to the innumerable learning resources of national and international level. The world level enhancement of skills, knowledge etc. in the students community is only possible by making the e resources available, bringing these by the skilled teachers through ICT. The teachers use Projector and screen for communication of informations, prepare soft copy of the topics with the help of PPT, various national and international materials of importance are also included and a broader approach is thus given to the class room teaching.

2. Introduction of New Courses- The IQAC had proposed introduction of PGDCA and DCA which was implemented from academic session 2018-19. There was a high demand for introducing M.Sc in Botany, Bio Technology and Microbiology and also increase in seats of Science stream in UG which has now been introduced from academic session 2020-21.

The IQAC of the institution consists of teachers from almost all the departments, one member from society, one alumnus of the institution, one representative of the students and is headed by one senior teacher. The quality factor in the field of higher education is to be taken care of and enhanced by this cell of the institution. In tune with the duties and expectations of the cell there is a tradition of regular meetings organized by it for pondering over the state of affairs related to the present schemes being followed and their strengths and weaknesses in order to decide the future course of action for quality improvement. The meetings of the cell are generally conducted twice in a session. First meeting is held either in the month of June or July and the second in the month of December or January. Apart from the other issues and processes governing the quality factor the teaching learning process is the cynosure of the whole system. The process is reviewed at intervals mainly in the IQAC meetings and functioning, functionality, response and valuable suggestions of the teachers are invited as well as those of the students are also gathered from their representatives. Their grievances and suggestions for strengthening the quality frame work are recorded and included into the minutes of the meetings. Reasonable and implementable suggestions take the shape of the future plan in the field of academics. Methodologies of operations discussed and learning outcomes are assessed at periodic intervals during the meetings.

Two examples of teaching learning reforms:

1. The Schemes of Advance-Slow learners and Mentor-Mentee was introduced by the IQAC initiatives through its meetings.
2. Starting of E-libray, E-resources of national and international repute in the main library.

##### Response:

The institution is a lead college of the district and adopts co-education. Hence it consists of students both boys and girls from all the nearby areas including town and villages. It puts almost all the efforts to respect and promote the constitutional morality and equality before the law of both the genders and not to discriminate on this very basis. Institution has certain committees especially constituted for looking after these areas of gender sensitivity like Gender Sensitivity and Gender Champion Committee, Committee Against Sexual Offences, Girls Common Room/ Hostel Committee etc. All the related committees conduct its meetings at regular intervals every year for chalking out the problems and issues being faced by the students and teachers. Their solutions are implemented and the responses are also welcome by the respective committees. The opinion of female teaching and non-teaching staffs are also received in order to enhance the environment of the institution in this respect.

Safety and security-So far as the safety and security of the marginalized sections of the society is concerned the campus is completely free from any sort of violence and misbehavior related to the girl students. So far no such incidences have been noticed or recorded by the administration. But the institution has already set up a mechanism to deal with any such future incidences or complaints.

- The related committees apart from looking after the tasks related to common room, hostel etc. are also entrusted with the task of counselling the students in any field of their apprehensions or problems.

Common room-There is a separate girls' common room for the students. It consists of all the basic amenities for them. They can even sit and study news papers and journals which are available for them in the area.

The Curriculum of many programmes contains topics related to Gender equity and Sensitization. It shows the seriousness and focus of the affiliating university and subsequently the institution towards this concern. In extra curricular activities the girls are specially trained in yoga for their all round development, self defence arts for defending themselves, special programmes related to their concern etc.

## 7.2 Best Practices

### 7.2.1 Describe two best practices successfully implemented by the Institution as per NAAC format provided in the Manual.

#### Response:

There are many practices in the institution which are part of its every academic session and may be considered as good for enriching the curricular and extracurricular mission i.e.Green Practices under the Science Club, Legal Aid clinic under the Department of Law, a Quiz Club functional in our institution, Thakur Chhedilal Interdisciplinary Discussion Forum, Law Coaching Classes for Competitive Classes etc. The two of the mentioned good practices considered to be the best are:

#### 1. Best Practice 1-‘The Quiz Club’

- This Club was established in the starting of the academic session 2019-20 with a view to initiate a healthy practice of acquainting and enriching the students about the general knowledge and general studies. The objective being a more fulfilling outcome in the form of a more matured and knowledgeable student and also acting and assisting in the field of competitive examinations.
- **Context-**The field of higher education is of immense help to the students seeking higher studies and knowledge of higher value. The students while accumulating knowledge and philosophical boost in their respective field of study at the same time they are wary of their future and settlement in life. The higher education can place them in a good stead specially in the field of higher teaching and professional fields. The practice of quizzing is such a magnificent and enlightening practice which improves the knowledge of the students at the same time strengthens their competitive skills. It helps them in various qualifying examinations in any competitions.
- **Practice-**There is a separate college committee constitutes specially for the functioning of Quiz Club. The committee consists of experts from the faculty of the college who are interested, experienced and at the same time qualified in the field. They prepare the question-answer and decide the ways and means of conducting the practice. It is decided to conduct the Quiz once or twice every month. It is for the committee to decide the time, place and format of the Quiz and even

after discussion with the interested students.

- **Evidence-**In the absence of any such initiatives the college was conducting such practices once or twice a year in which the students always showed high enthusiasm by participating in high numbers. There are many success stories of students who were regular participants in such activities. The time this practice was started there is a sense of huge enthusiasm amongst the students from different disciplines participate and score good in monthly Quiz Competitions. The more effect of such initiative will be seen in near future for sure.
- **Problems Encountered/Resources required-** When this very practice was initiated in the college the student turn out were minimal and there was less interest in the students. But after two months and spread of awareness of any such activity in their institution now more and more students have come to know its importance and those from different disciplines are participating and enriching their knowledge. As such there is no huge problem in its practice but while all the classes are functioning a separate place or time is hard to be found for conducting this practice. Therefore, many a times it is decided to be conducted on Sundays which is a holiday. The students some times suggest that for better functioning of the activities of this club and quizzing practice it may be an opportune day.
- **Notes-**Such practices are kind of extra-curricular activity which is entertaining at the same time enriching in knowledge with a view to fulfilling the ultimate aim of earning bread and butter. The students take much more interest in such knowledge oriented practices even after their hectic curricular schedules.

## (2) Best Practice 2- 'Thakur Chhedilal Interdisciplinary Discussion Forum'

- **Objective of the Practice-**The role of interdisciplinary discourse in any academic institution is of high academic value. Such a practice instills higher philosophical acumen of any field of knowledge in the students. In line with the healthy practice of improving the students' intellect in many higher educational institutions of repute, this institution also initiated the practice of such interdisciplinary discourse under a separate forum named after the great barrister and freedom fighter on whose name this institution is established. 'Thakur Chhedilal Interdisciplinary Discussion Forum' is functioning from the academic session 2019-20.
- **Context-**This Forum is initiated in the context of improving the intellectual aspect of students' persona as well as catering to the needs for India becoming a world leader once again. Such a forum is meant to provide the students a platform where they can discuss any given area of importance and get others' views and critique.
- **Practice-**There is a separate college committee constituted for the smooth and qualitative functioning of this forum. There is one Co-Ordinator and two other members. The forum is to organize the discussion once or twice in a month. It can even increase its number may be every week based on the interest and willingness of the participating students. Due to engagement of curricular activities Sundays are supposed to be the right day for the purpose and for conducting any such practice extensively and purposefully.
- **Success Evidence-**There are many students barring discipline lines who are active in this forum and feel highly benefitted from such practices. The short term benefit can be seen through the experiences of the students. So far as the long-term benefit is concerned it will be seen in their persona, in their settlement in life while earning their livelihood, contribution of the students in their professional commitments, in the society etc. They can become boon for the society, can act

as a responsible citizen of the country etc.

- **Problems Encountered/Resources required-** Some of the problems encountered being the opinion differences while initiating such an initiative, unavailability of time span for conducting the activities of this forum, initial less responsive attitude of the students etc. The students started getting awareness about the concept and its outcomes. Presently it has taken the shape of a highly popular initiative of the institution for the overall benefit of the students. The teachers very enthusiastically become part of this forum and often contribute in different ways and capacities.
- **Notes-** It is the aim of the forum to spread its reach to the students of other institutions and education forums of the district so that more and more students can reap the benefits of this initiative. Apart from the curricular and extra-curricular functions of an academic institution this intellectual enhancement initiative can do a lot for the career advancement of the students.

### 7.3 Institutional Distinctiveness

#### 7.3.1 Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

**Response:**

Performance of the Institution in One area distinctive to its priority and thrust:

The institution functions from its campus in Janjgir and district of Janjgir-Champa which is situated in the district headquarter. The one area distinctive to its priority and thrust is imparting of some PG level programmes and Research Programmes which are its one of the distinctive features. These are not available in other nearby i.e. either in this district or other nearby districts and are on very nominal fees. Students opting for courses like post graduate courses in Law, many other post graduate courses like Botany, Microbiology, Biotechnology, DCA, PGDCA etc. this institution is the only institution. The various distinctive features like research programmes in 2 disciplines i.e. Economics, Sociology, computer programmes, PG programmes etc. But the P.G. programme in the field of legal study is one of the special and distinctive features of the college. This programme was started in the academic session 2012-13. The sanctioned seats allotted by the then Bilaspur University, Bilaspur to the college department of law was 20. The college admit students to this programme in present sanctioned capacity of 20 from other districts and even other nearby states. UG, PG in Philosophy, UG in Psychology and Home Science are also not available in other nearby academic institutions due to which reason students from other districts and distant places of this district come for study here. It is also the only government college of the university where LL.M degree is available at a very nominal fee as compared to the other private institutions offering it in other districts of the state. It is even the only government institution imparting this very programme in the

university. The eligibility for doing this programme is pass with 55% marks in LLB three year or five year integrated programme. Those practising in any court of law can also be admitted with fulfilling other conditions of the affiliating university. The student intake of this programme is very diverse and experienced as advocated, other professionals, government officials are pursuing this post graduate programme. The college through this programme serves the legal fraternity which acts in enriching the academic environment of the institution. Such other programmes as mentioned earlier also acts in enriching the academic environment. The students studying PG in Philosophy, Home Science are often the rank holders in the university merit list.

It is therefore the responsibility as an old and reputed academic institution to serve the society of the area and even the students of very diverse socio economic conditions. The students under the guidance of the qualified teaching faculty of the institution are able to qualify in various competitive examinations mainly at state level like Civil Judge, Prosecution officers, School teachers, Banks, Police Department, Defence etc. The old history and eminence of the institution having many distinctive features entrusts upon it great responsibility in the area of achieving academic excellence.

There are facilities of opting for higher education in the field of Arts, Commerce, Science and Law in this institution which is very distinctive to other educational institutions imparting higher education in the region. The students from different districts and some from nearby states also opt for the programmes offered by this institution. The curricular activities are conducted by a good number of highly qualified teachers who come from diverse background and even from different states. The extra curricular activities are enriched by the presence of a huge play ground, a big indoor stadium and other facilities. It provides a plethora of opportunities to the students in choosing from a variety of indoor and outdoor games for their overall physical and mental development. The institution also conducts a number of programmes related to health and hygiene which are also equally helpful for students health awareness. The library facility is also the cynosure of all the facilities available in the institution. The institution apart from providing quality education in diverse fields of academics is also having dearth of infrastructural and other facilities which requires to be fulfilled in the time to come as soon as possible. The future is of ICT and at present all the teachers are using one or the other facility and it also requires to be enhanced to meet the national and international standards of teaching-learning processes.
