- The effective date of implementation of the Project will be the date of receipt of fund by the institution.
- The tenure for the Minor Research Project will be 2 year, which would be permissible only under special circumstances and will be without any Financial Assistance.
- 3. On receipt of this letter the Principal Investigator must sign and return the Acceptance Certificate as enclosed duly countersigned by the Principal within 3 month of issue of this letter, failing which the approval should stand withdrawn.
- In case, the grant is not settled within six months from the date of completion of the project, the same will lapse and no representation will be entertained on this behalf and Principal Investigator has to refund the whole grant.

TECHNICAL REPORT

"COPYRIGHT EMERGING CHALLENGES AND OPPORTUNITIES SPECIAL REFERENCE TO CHHATTISGARH"

01. OBJECTIVES OF THE PROJECT-

With the advancement in the digital technology, the distribution of the copyrighted material on the internet has brought about a drastic change in the pre-existing laws. Unfair use and illegal downloading of copyrighted material such as software, videos, songs etc. have developed into a major problem in the digital domain. To overcome these problems several technological and legal measures have been taken up such as development of tools like Encryption, Digimare, Watermark, besides faming of various international treaties and agreements including TRIPS, Anti-counterfeiting trade agreement (ACTA), WIPO Copyright Treaty (WCT), WIPO Performance and phonogram Treaty (WPPT) etc. Indian Copyright Act aller amendment of 2012 seems to be effective enough to resolve the issues concerned with infringements in the digital domain hence debate is going on if India should sign WCT and WPPT and the matter is still under consideration of the Government of India. The development in the digital environment has altered the boundaries for the copyright holders to look at the protection of copyrighted material through various techniques. The present article deliberates about the Indian Copyright act, various international copyright treaties, limitations and exceptions provided by trips and also look towards the usefulness of various treaties available for the digital domain. Furthermore, steps to control the misuse of copyrighted material are also discussed. The MRP concludes with some suggestions and ideas that could be useful for regulating the unfair use illegal downloading of the copyrighted material and emerging challenges opportunities special reference to Chhattisgarh. The basic objective of granting intellectual property rights is to encourage human intellectual creativity. Due to the wide scope of intellectual property rights, it was considered.

02. SUMMARY OF THE FINDINGS

In numerous respects, copyright law today serves well the interests of authors, those to whom authors assign or license their rights, and the public, but in some important respects, this law is askew. The last few decades have witnessed dramatic changes in the copyright landscape, especially with the advent of global digital networks and technological tools that are widely used to access and interact with copyrighted content, so it is not surprising that courts and Congress have found it difficult to adapt the law in a coherent and principled way. This project addresses those changes and difficulties and the ways in which current copyright law does not serve well, the interests of those it affects. By articulating principles of a good copyright law and examining existing Indian copyright law in light of those principles, members of the CCRS have sought to achieve two main goals. The first is to explain the normative grounding of particular copyright rules that do comport with these principles. The second is to offer recommendations for change so that copyright law can better be adapted to meet the challenges of the day in a way that is principled and balanced, and that would command respect from the public as well as from copyright owners.



03. CONTRIBUTION TO THE SOCIETY -

Today works reasonably well in some domains, it can be improved and should be refined in light of dramatic technological advances. Among us are law professors, lawyers from private practice, and lawyers for copyright industry firms. The goal of the CPP was to explore whether it was possible to reach some consensus about how current copyright law could be improved and how the law's current problems could be mitigated.
