Dear Sir/Madam,

As you might be aware Ministry of Human Resource Development (MHRD), Government of India has notified on 18th March 2020 that National Academic Depository (NAD) to be implemented as a permanent scheme by **DigiLocker** as a single entity. It was also proposed in the National Education Policy 2020 that Academic Bank of Credit will be managed by DigiLocker and enable Education Institutions to deposit, transfer, redeem and verify academic credits of the students.

- 2. **DigiLocker** is a flagship initiative of Ministry of Electronics & IT (MeitY) under Digital India Programme. DigiLocker aims at 'Digital Empowerment' of citizen by providing access to authentic digital documents to citizen's digital document wallet. The issued documents in DigiLocker system are deemed to be at par with original physical documents as per Rule 9A of the Information. Technology (Preservation and Retention of Information by Intermediaries providing Digital Locker facilities) Rules, 2016 notified on February 8, 2017 vide G.S.R. 711(E).
- 3. Under the NAD scheme all Universities have to register in https://nad.digitallocker.gov.in or https://nad.gov.in/ and upload data in standard input format for publishing digital awards. Once the data is published on the DigiLocker, the degrees/mark sheets can be accessed by the students and verifiers after duly registering on the DigiLocker portal. This service is Free of Cost for students and Universities.
- 4. In view of the above it is requested to issue directions to all universities in your State/UTs to register in NAD and issue digital certificates to your students.

Subject: Implementation of National Academic Depository (NAD) -regarding

Sir,

The Government of India is committed in bringing the administrative and academic reform through the use of technology for delivery of efficient services to all stakeholders. Education engages with almost every citizen of the country and the Government is keen to create quality infrastructure that will facilitate delivery of services to citizens and will also facilitate academic institutions in performing their core functions. A step in this direction was the launch of the National Academic Depository (NAD) by the Hon'ble President of India on 9th July, 2017.

- 2. The Government in exercise of powers conferred under section 20(1) of the University Grants Commission (UGC) Act, 1956 had designated UGC as the authorised implementing agency of NAD and was entrusted with the task of implementation of National Academic Depository (NAD) (vide this office letter No. 5-3/2016-U.Policy dated 31st October, 2016). In order to operationalise NAD, UGC (the authorised implementing agency) entered into a tripartite agreement with NSDL Database Management Limited (NDML) and CDSL Ventures Limited (CVL) on 22.11.2016 for a period of three years.
- 3. Since the launch of NAD, many academic institutions including various Central Universities, State Universities, Private Universities, Central Higher Educational Institutions, School Boards etc., are uploading their academic awards on NAD. Also, many students are using NAD for accessing their academic awards online and verification seeking entities are also using NAD for verification of academic awards.
- 4. The period of tripartite agreement signed between UGC, NDML and CVL has ended on 22.11.2019 and the following has been decided with regard to further implementation of NAD:
 - (i) NAD shall not be implemented through NDML and CVL and to take necessary action in this regard.



(ii) NAD to be implemented as a permanent scheme without levy of any user charges, by Digilocker through the Ministry of Electronics and Information Technology (MeitY) as a single entity.

(iii) UGC to be authorised to implement NAD as a permanent scheme, in co-

operation with the Digilocker.

(iv) To undertake necessary action for delinking all applications currently using NAD portal through NDML and CVL and linking them through Digilocker.

- In light of the above UGC may ensure the following:
- (i) The academic awards lodged on the portals of NDML and CVL are seamlessly transferred to NAD/Digilocker.
- (ii) UGC the implementing body of NAD shall ensure its implementation through Digilocker, an entity owned by Ministry of Electronics and Information Technology.
- (iii) UGC may enter into a Memoradum of Understanding with Digilocker for smooth implementation of NAD clearly delineating the rights and responsibilities among them. However, both the Ministry of Human Resource Development and Ministry of Electronics & Information Technology may be kept informed in this regard.
- (iv) UGC to finalise various technical issues/various formats for uploading of academic awards/creation of student account, mapping of academic awards, procedure for verification etc in consultation with Digilocker.
- (v) UGC to ensure that reports on various parameters such as registrations/academic award upload, verification completed are provided to the Ministry as and when called for by the Ministry.
- In view of above, UGC is requested to kindly take necessary action accordingly for the smooth implementation of NAD.
- This issues with the approval of the competent authority.
